I played there two years and then I came back home and, uh, and so, uh, and I'll come back home and, you know, you start living a life that you never thought you live.

You know, we were just I don't have a bond, just ride around in my car.

So, yeah, I want to jump in here. Okay. So, uh, we ended up, uh, you know, we end up jumping across a guardrail, going to the brush that was over on the right hand side.

Probably about 30 seconds later, we hear these voices yelling at us, telling us, passenger, don't move.

I said, many people are trying to blame this on me. And I tell them I didn't do this man. And so they act like they don't want me talking to him. And so he our game was interview told them what had happened, told them they didn't do it. It was it was different. It was it was this is what happened.
